## Privacy policy

Processing of your data by Bennix India Foundation e.V.

When you join Bennix India Foundation e.V. as a member, you provide us with your personal data, such as name, title, address, e-mail address, telephone number, bank details, date of joining, etc.

We process your personal data to handle your inquiries or for the purpose of membership administration and processing of donations in particular:

- to process your declaration of membership,
- for the administration of your membership,
- for communication between fhh and you,
- for sending invitations, information and appeals (by circular mail)
- for the administration of membership fees and payment transactions
- for the processing of donations
- for the analysis of a balanced membership structure

A further use of the personal data or a passing on to third parties does not take place. The data you transmit to us will be treated confidentially. The transmission of your personal data to us is always voluntary.

We process your data only with your express consent or if it is necessary to fulfill the above purpose or to protect the legitimate interests of fhh.

We will regularly send you information about fhh by mail, provided you consent to this. You can revoke this consent at any time. For this purpose, an informal communication by e-mail to us is sufficient.

As a matter of principle, we only store your personal data for as long as is necessary to achieve the above-mentioned purpose. If the purpose of storage ceases to apply, if you revoke your consent or if you request us to delete your data, your personal data will be deleted in accordance with the statutory provisions. Mandatory legal provisions - in particular retention periods - remain unaffected.

Within the framework of the applicable legal provisions, you have the right at any time to obtain free information about your stored personal data as well as a right to correct, delete your data and to restrict or object to processing. You have the right to revoke the declaration of consent under data protection law at any time by e-mail to [info@fbennix-india-foundation.de](mailto:info@fbennix-india-foundation.de). The revocation does not affect the lawfulness of the processing carried out on the basis of the consent. You also have the right to lodge a complaint with the data protection supervisory authority.
